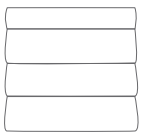

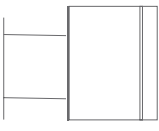

Cutting: Cold Cut, Ultrasonic, Crush Cut or Laser

Seaming / Hemming: Thermal, High-Frequency, Ultrasonic or Sewing.

## CARE AND CLEANING

---

Remove dust with vacuum cleaner or compressed air. Do not scrub. Do not use solvents or any abrasive substance which might damage the coating on the fabric. Clean with a sponge or a soft brush dipped in soapy water using mild detergent. Rinse with clean water. Leave the shade down until completely dry. You can also rub the fabric very gently with a clean white pencil eraser to remove small stains.
